CONTINUING TO HAVE AN IMPACT

When the pandemic hit I was really worried about how I could continue to have an impact. Especially since initial reports coming from the Polaris Project were showing an increase in trafficking crises calls due to the pandemic. I felt the weight of sitting at home knowing vulnerabilities were increasing for at-risk populations. That's when I remembered about CASA, an organization that supports children in the foster care system. I knew from my work the ways in which the foster care system intersects with trafficking and that homeless youth are especially at risk of being targeted by traffickers. The pandemic gave me an opportunity to focus on those issues here in my local community because my busy travel schedule came to a standstill.



CASA (Court Appointed Special Advocates) is a volunteer

org that provides advocacy for children in the system. Becoming a CASA requires 30 hours of training, background checks and an appointment from a judge. CASAs exist to be a steady presence for children as they navigate really tough stuff. Statistics show that children who are appointed a CASA are 97% less likely to be re-homed in an abusive situation. Sometimes it just takes one person caring to change the life of a child. CASA does that.

I am celebrating my one-year anniversary of becoming a CASA. Over the past twelve months, I have been a CASA to three incredible kiddos who have persevered through some of the biggest challenges you can imagine. I have learned so much from being immersed behind the scenes of court hearings, DHS meetings, teacher conferences, foster parent visits, doctor appointments, custody meetings and more. All the while trying to imagine what it much be like to go through all that as a child alone.

Being a CASA has changed my life. It's given me hope to see all the caring people who work in the foster care system. It's also given me the ability to focus locally. CASA is a nationwide org with offices in nearly every city. Jackson County, where I live, has about 200 foster care kiddos on the waiting list for a CASA. CASA is always looking for more advocates. Visit your local CASA office. Every Kiddos deserves just one consistent caring adult!

PLAY SCALE COURTROOMS

Imagination Dollhouses for Children has been designing, building and donating handmade dollhouses to nonprofit organizations working with abused children nationwide since 2008. In 2021, Imagination Dollhouses for Children became a registered 501(c)(3)nonprofit organization.

With a mission to provide, at no cost to the organization, a well-built, colorful, and easily navigable dollhouse in which children in crisis will feel comfortable exercising their imagination. Play Scale Courtrooms are also provided at no cost to nonprofit organizations that must prepare young children for the ordeal of testifying in court.

Courtrooms are scary - even for adults! Imagine how a child feels. Play Scale Courtrooms bring the courtroom down to a child's size and make it less threatening. Children who will have to testify are shown the whole courtroom and where various people will sit, including the defendant and the child. When a child can see the inside of a courtroom in a nonthreatening setting, the hope is that the child will feel more in control.
